 - **Freestanding signs:** Site plan showing all existing and proposed buildings and structures, proposed sign location, accurate distances from lot lines and other structures, full sign support structure and sign face(s) with all dimensions, including gross height and color drawings of sign copy.
- Lighting Plan:** Narrative detailing whether the sign will be internally or externally lighted, the type of lighting to be used, and the proposed hours of illumination.
- Owner Authorization:** if you are not the owner, a letter authorizing you to apply as their agent
- Application Fee:** see City of Evert Schedule of Fees Form
