**272.01 Commission Established.**

The City Planning Commission heretofore created pursuant to Act 285 of the Public Acts of 1931, State of Michigan, is continued. The Planning Commission shall be known as the Planning Commission of the City of Ewart, Michigan.

**272.02 Members.**

The Commission shall consist of nine (9) members, as follows: The Mayor, one (1) administrative officer of the City who shall be appointed by the Mayor, one (1) councilman who shall be appointed by the City Council, and six (6) members who shall be appointed by the Mayor subject to the approval of the City Council.

**272.03 Terms.**

The terms of office of the ex-officio members shall correspond to their official tenures, except that the term of office of the administrative officer shall terminate with the term of office of the Mayor. The term of office of the other members shall be for three (3) years,

except that upon the first appointment two (2) members shall be appointed for three (3) years, two (2) members for two (2) years, and two (2) members for one ( 1) year.

**272.04 Removal; Vacancies.**

Members of the Commission may be removed in the manner and for the reasons prescribed in section 3 of Act No. 285 of the Public Acts of 1931, as amended.

Appointments to fill vacancies shall be made in the same manner as the original appointment.

**272.05 Powers.**

The powers of the Commission shall be those prescribed In Act No. 285 of the Public Acts of 1931, as amended.

**272.06 Meetings.**

Regular meetings of the Commission shall be held at the City Hall on the last Monday of each month, at 7:00 p.m., unless the Commission shall by resolution, fix some other time and/or place. Special meetings may be had upon the call of the Chairman.
